held to formulate a common code/guidelines for engagement of Guest Faculty across constituent colleges of NSCBIHL

In pursuance of the meeting notice issued by the Registrar, NSCBIHL, Sri Vijaya Puram vide No. 1-1/NSCBIHL/Gen/2026/24 dated 29.07.2026, a meeting of the Principals of all constituent colleges was convened on 29.07.2026 at 3.30 P.M. at TGCE, Sri Vijaya Puram, to discuss and formulate a common code/guidelines for the engagement of Guest Faculty across all constituent colleges of the University, under the Chairmanship of Dr. S. Jayakumar, Principal, ANCOL and Registrar, NSCBIHL.

The Chairman welcomed the Principals present and stated the purpose of the meeting, namely, to arrive at uniform and common code/guidelines for the engagement of Guest Faculty to be followed by all constituent colleges of NSCBIHL. After detailed discussion, the following decisions were taken with effect from the current academic session onwards, until superseded by formal guidelines to be issued by NSCBIHL:

1. Marks/score shall be the deciding factor for engagement of Guest Faculty. The maximum marks admissible for experience shall be restricted to 10 (ten). In the event of a tie amongst candidates at the maximum permissible experience marks (10), the score obtained shall be the deciding factor.
2. For the purpose of computing experience under the local category with continuous 10 years education in these Islands shall be considered on the basis of local certificates issued to this effect, and not merely on the basis of an Islander Card or any other document.

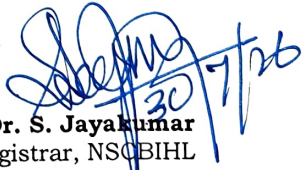
3. Ph.D. holders, whether belonging to the mainland or to the Islands, shall be accepted as eligible candidates; however, preference shall be given to the local candidates.
4. Preference shall be given to local candidates, and mainland candidates shall be considered only in the event that a locally eligible candidate is not available.
5. Marks for experience shall be allowed only where the candidate has gained such experience in the local colleges under the A & N Administration.
6. Preference under the local category shall be extended to eligible candidates who are themselves Islanders or wards of Islanders.
7. Experience Certificates furnished by mainland candidates shall be countersigned by the concerned Secretary (Education), or the equivalent competent authority, of the State/UT concerned.
8. From the ensuing academic year, NSCBIHL shall issue formal guidelines governing for the engagement of Guest Faculty across all constituent colleges, superseding the arrangement recorded herein.

The above resolutions (1 to 8) were unanimously adopted by all the Principals present and shall stand applicable uniformly to all constituent colleges of NSCBIHL, namely, Andaman Law College, DBRAIT, JNRM, MGGC Mayabunder, TGCE, and ANCOL for engagement of Guest Faculty from the current academic session onwards.

The meeting ended with a vote of thanks to the Chair.
